Dear Conferees:

The Green Budget Coalition, representing over 30 statewide and regional environmental and conservation organizations from around the Commonwealth, has been advocating for adequate funding for our environmental agencies for more than two decades. We greatly appreciate that both the House and Senate included increases for the Coalition's priorities during the budget process. However, we still have a long way to go to reverse the deep cuts to our environmental agencies over the past decade and to reach our goal of 1% of the budget for the environment.

**To that end, the Coalition requests that the conference committee adopt the following numbers for the final budget:**

**Department of Conservation & Recreation (DCR): State Parks & Recreation (Line-Item: 2810-0100)**

**Support the level in the House budget: \$45,736,288**

This line-item supports the stewardship, management and safety of our parks, parkways, beaches, forests, pools, skating rinks, and campgrounds. DCR is responsible for 450,000 acres of land, spread across more than 250 properties. Over the past few years DCR's presence at properties around the state has noticeably declined, with only two rangers covering the entire Berkshires. The House funding level would ensure that our parks, campgrounds, and beaches are staffed and safe, facilities and trails are maintained, and DCR can better steward the amazing array of natural resources found on these properties. The increase proposed by the House is urgently needed to ensure the public's enjoyment of all that DCR properties have to offer.

**Department of Environmental Protection (DEP) (Line-Item: 2200-0100)**

**Support the underlying number in both the House & Senate budgets: \$31,505,245 (with earmarks \$31,832,245 and \$31,922,245 respectively)**

DEP has a broad set of critical responsibilities for public health and safety, including ensuring clean air and water, watershed planning and permitting, the safe management of toxic chemicals, enforcing environmental laws, reducing solid waste, the timely cleanup of hazardous waste sites and spills, and the preservation of wetlands and coastal resources. The agency lost more than 100 employees during the Early Retirement Incentive Program and this funding is needed so DEP can continue to replace critical staff.

**Division of Ecological Restoration (Line-Item: 2300-0101)**

**Support the level in the Senate budget: \$2,100,000**

There are 3,000 dams and 30,000 culverts across the state, many of which have long-exceeded their design life and are vulnerable to increasing threats from severe storms and flooding. Many communities lack the technical and financial capacity to address this legacy infrastructure that impacts environmental health, public safety, municipal budgets, and community resilience to climate change. Requests for DER's assistance to remove old dams, upgrade substandard culverts, and complete other restoration actions far exceed the Division's current resources. The Senate's increase will allow DER to assist more communities and take on additional critical projects each year.

Our final priority was funded at the same level in both budgets, and we hope to maintain that number in the final budget:

**DCR: Office of Watershed Management (Line-Item: 2800-0101)**

**House & Senate: \$1,523,447**

This office is responsible for providing invaluable technical assistance to municipalities, working with nearly every city and town in the Commonwealth. The increase in both budgets would allow the Office of Watershed Management to hire back staff that had to be cut as a result of fewer funds, including a Flood Hazard Management Program Mapping Coordinator and a Water Resources Scientist.
