DID YOU KNOW?

- In the 1800s, the Childs River was known as a world-class salter brook trout river
- The Falmouth Rod & Gun Club initiated and managed the transformation that took place from 2014 (initial discussions) to present
- A private-public partnership was formed that involved the towns of Falmouth and
 Mashpee as well as local, state, and federal organizations / agencies
- With a focus on the environment and conservation, the partnership rechanneled the river for trout propagation and survival, and converted abandoned cranberry bogs to wetlands for other wildlife to thrive
- Once again, the river has become a coldwater fishery, a wildlife sanctuary, and a site for recreational viewing and environmental education


What Happened Here?

- Cranberry bogs were acquired from the towns of Falmouth and Mashpee
- Earthen dam at the southern mill pond was dismantled
- Non-functional fish ladder near the southern pond was covered
- Culvert beneath Carriage Shop Road was replaced
- Water control structures throughout the project were removed
- River was rechanneled through the bogs and ponds
- Cranberry bogs were restored to natural wetlands by removing sand and filling irrigation ditches
- Shallow ponds were created in the wetland areas for migratory waterfowl and other wildlife
- Native plantings and woody
 materials were added to shade the
 river, improve native ecosystems,
 and assist the hydrologic and
 geomorphic processes


