Biographical Sketches

DeeDee Holt

A professional career including positions in both the for-profit and non-profit spheres holding executive roles in software development, pension plan management, and large-scale fundraising event management. DeeDee retired in 2004 as a database consultant working with non-profit organizations. Career opportunities have taken her to Manhattan, Denver, Chicago, and Cambridge before retiring to Chatham. DeeDee holds an MBA in marketing and project management, a CLU designation, and a bachelor's degree in English and Philosophy from St. Lawrence University. As a volunteer, she has served for 7 years on the Chatham Conservation Commission, the last 4 as Chair, and is currently a member of Chatham's Planning Board. Patricia Hughes

Pat is the past Director of the Marine Policy Program at the Center for Coastal Studies in Provincetown. She collaborates with Center scientists and others to bring unbiased science to public policy discussions, including coastal water quality, state and regional ocean planning initiatives and coastal change. Pat has worked on shellfish aquaculture projects and was a member of a team of scientists assessing the feasibility of North American lobster aquaculture, working on projects in Massachusetts, Maine and California. She previously worked for the Cape Cod Commission and the Massachusetts Coastal Zone Management Program. Pat served on the Massachusetts Coastal Erosion Commission in 2015 and recently completed her second term as a Brewster selectman. She served on the APCC board from 1982 to 1984

Jack is an environmental attorney with more than thirty years of litigation experience. As an Assistant Attorney General for the State of Connecticut, Jack enforced state and federal environmental protection laws on behalf of the citizens of Connecticut. As an attorney at Connecticut Fund for the Environment/Save the Sound in New Haven, Jack continued litigating environmental enforcement actions using the citizen suit provisions of the federal Clean Water Act and Clean Air Act.
