On advice of the State Staff Judge Advocate one (1) series of emails have been withheld as they are subject to the attorney-client privilege.

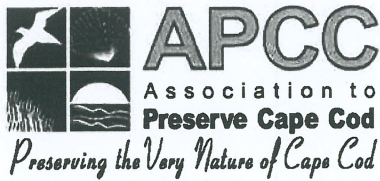
The Military Division will not assess a fee for the production of the documents. The waiver of a fee in this instance is not a waiver of statutory fees for any further or future record requests.
